ACCEPTANCE OF PLACE FOR FULL FEE PAYING INTERNATIONAL STUDENT

In accepting this place at Napier Girls' High School for _____
I agree to the following:

- 1 My daughter will abide by all the Rules and Regulations of Napier Girls' High School set out in Schedules I and II. I acknowledge that if she breaches any of these rules or regulations then I may be required to remove my daughter from the school.
- 2 I agree to pay all tuition and accommodation fees in full a year in advance unless other arrangements are made with the Principal.
- 3 I irrevocably appoint and authorise the Principal
- 4
- 5 of the school (or such other person as may be appointed to carry out the Principal's duties) to:
 - 5.1 Receive information concerning the student including but not limited to medical, education or welfare information; and
 - 5.2 Provide consent in respect of any activity carried out or authorised by the school, and/or that may be necessary to be given on the student's behalf in the event of a medical emergency where it is not reasonably practicable to contact the parents; and
 - 5.3 To advise the student's homestay hosts or Hewett House of all matters and information required to be provided to parents of any student under the Education Act 1989.
- 6 The school will not be liable for:
 - 6.1 Any damage or harm caused to the student or the student's property arising out of a student's homestay or Hewett House accommodation; and
 - 6.2 Any damage or harm caused to the student or the student's property while attending the school, unless the harm was as a result of gross negligence on the part of the school; and
 - 6.3 Any damage or harm caused to the student or the student's property outside of normal school hours and in the case of the student's property, will not be responsible for damage to such property that may occur outside the school's premises.
- 7 This agreement may be terminated by either party at any time upon one month's written notice. If the agreement is terminated the refunds policy as outlined in Schedule II will apply.

8 This agreement will be construed and will take effect in accordance with the domestic laws of New Zealand. In relation to any legal action or proceedings arising out of or in connection with this agreement I irrevocably submit to the jurisdiction of the Courts of New Zealand, and waive any objection to proceedings in any New Zealand Court or forum on the grounds of venue or on the grounds that the proceedings have been brought in an inconvenient forum.
